

Disclosure and acknowledgement of Risk:

The Next Ferns event, including any initial screening tests, assessment activities and development programmes, involves strenuous physical and full contact sports activities. The activities above contain elements of risk, including serious injury. The risk is mitigated by activities being structured and sequenced, and being supervised by trained instructors, but the risk cannot be reduced to zero. I understand that there are certain risks involved with physical activity, particularly in relation to a contact sport, that cannot be reduced to zero. I know that I am able to ask questions of the supervising instructor to gain a better understanding of any activity, and that the final decision regarding whether I take part in any activity or not is mine (bearing in mind that inability or unwillingness to take part in an activity may have a bearing on selection for further involvement in the programme). I will follow the instructions of the supervising instructor, and I accept that any failure to do so may increase the risks involved in any activity.

I authorise New Zealand Rugby (NZR) NZR and any medical staff onsite to instigate any medical assistance and treatment required in an emergency.

- to assess your physical attributes and athletic potential in relation to rugby performance
- to help identify individuals who may be suitable for further rugby development opportunities
- to contact you with feedback or follow-up opportunities if you meet certain performance benchmarks

- to understand the overall participant profile to help us improve future combine events
- to ensure the safety and wellbeing of all participants during the event
- to meet any legal, regulatory, or safeguarding obligations related to participant data, and
- to manage the logistics and administration of the event (e.g. registrations, attendance, and communications)

NZR will only share your personal information where necessary for any purpose related above unless you agree to any further disclosure (for example, where you are selected for additional performance testing). Providing your personal information is optional, however, if you choose not to then you may not be able to participate in any Next Ferns Event.
