

## Take a picture of you in the stands at Black Ferns v Australia Women match ("the Competition")

### Terms & Conditions

1. Information on how to enter the Competition forms part of the terms and conditions of entry. Entry into the Competition or acceptance of any prize is deemed as acceptance of these terms and conditions.
2. New Zealand Rugby Commercial LP, a limited partnership registered in New Zealand, acting through its General Partner, New Zealand Rugby Commercial GP Limited, 100 Molesworth Street, Thorndon, Wellington 6011, is the promoter of this Competition ("**the Promoter**").
3. This Competition is not in any way sponsored, endorsed or administered by, or associated with, Facebook, Instagram or X. Any queries, comments or complaints about the Competition must be directed to the Promoter and not to Facebook, Instagram or X. In participating in the Competition, you are providing information to the Promoter and not to Facebook, Instagram or X. To the extent permitted by law, you agree to release Facebook, Instagram and X from any and all claims and demands arising out of or in connection with your participation in the Competition or with any of the prizes offered.
4. The Competition is open to New Zealand residents of any age who are ticket holders of and are attending the Match. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion
5. Employees of the Promoter and New Zealand Rugby Union Incorporated ("**NZR**") as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible to enter the Competition.
6. The winner of the Grand Prize agrees to the Promoter sharing their photo on the stadium big screen for the Black Ferns v Australian Women match, held at Sky Stadium, Wellington, on Saturday 12 July 2025 ("**Match**"), announcing them as the winner and his or her guest, including their full name for no compensation. This is at the Promoter's discretion.

### Competition Entry

7. To enter the Competition, you must:
  - (a) Take a picture of you in the stands supporting our Black Ferns team at the Match.
  - (b) Scan the QR code presented on the stadium big screen that will take you to our photo submission website.
  - (c) Successfully submit your photo through the photo submission website while completing the required steps, including accepting any relevant terms and conditions and/or privacy policy, and optionally select whether or not you would like to receive communications from the Promoter.
8. Upon entering the Competition, you grant the Promotor a non-exclusive, non-revocable, royalty-free, worldwide licence to use, reproduce, publish and display your photo in any media or distribution method, including publication on websites and internet applications without restriction and without making any payment to you, for the purpose of promotion of the

Competition as the Promoter sees fit. Such use will be at the Promoter's discretion and the Promoter is not obligated to use, reproduce, publish or display any photos.

9. Only one entry per person is allowed and multiple entries will result in an entrant being disqualified.
10. Details of the Competition, including details of the entry process will be communicated via social media, an eDM newsletter to the Promoter's fan database, on the screen at the Black Ferns signing event at Shed 6, Wellington on Friday 11 July 2025, the relevant stadium ground announcer for the Match, and shown on the Match's stadium big screen.
11. The Promoter reserves the right to remove, have removed or disqualify any entry that does not meet these terms and conditions at any time without notice.

### Your Content

12. Your photo must:
  - (a) not include any objectionable material;
  - (b) be fit for public display, not show any act that is dangerous or offensive to the public or that may damage the reputation of the Promoter or NZR (as determined in the Promoter's sole discretion); and
  - (b) not be digitally enhanced or modified, except by using the enhancement functionality provided by Instagram, Twitter or X
13. You must obtain appropriate consent from other people or the owners of property that is identifiable in your photo enter it into the Competition (in accordance with these terms and conditions) prior to entering the Competition.
14. The Promoter reserves the right to remove or disqualify any photo that does not meet the above conditions at any time without notice.
15. You warrant that the photo does not infringe on the moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim or interest in the photo. You fully indemnify the Promoter and NZR against any claims arising from the display or use of your photo.

### Competition Period

16. The Competition commences Saturday 12 July 2025 at 3:45 pm (NZT) and closes Saturday 12 July 2025 at 5:00 pm (NZT) (**Competition Period**). Entries received after the Competition Period will be ineligible to enter the Competition.

## The Prizes

17. There are three (3) separate Competition prizes available, consisting of:
  - (a) 1 x double pass sideline haka experience for the All Blacks v France match held at Sky Stadium Wellington, on Saturday 12 July 2025 ("**Grand Prize**") or;
  - (b) 2 x \$100 NZD All Blacks Store Voucher.
18. One (1) individual will be selected as the winner for each Competition prize. Each winner will be chosen via random draw. Participants are eligible to win only one prize.
19. The Promoter reserves the right to disqualify any winner who does not comply with these terms and conditions and select a replacement winner in accordance with these terms and conditions.
20. Once determined, the Prize winner(s) will be notified directly via text message during half time of the Match and the Grand Prize winner will be announced via the Match stadium ground announcer.
21. The right to receive any prize is conditional upon the winner contacting the Promoter within 30 minutes of being notified. If the winner cannot be contacted or does not claim the prize within this time, the Promoter reserves the right to withdraw the prize from the winner and redraw a replacement winner.
22. The prizes only include items as stated in clause 17. The Promoter is not responsible for the payment of any duties, fees or taxes, or any other expenses incurred in taking up the prize. Unless expressly stated in these terms and conditions, all other expenses are the responsibility of the prize winner (and their companion if applicable), including but not limited to cost of obtaining current passports, visas, meals, spending money, other transport that may be required including transport to and from departure and arrival points, transfers, drinks, incidentals, mini-bar, laundry, room service, telephone calls, activities, gratuities, services charges, insurance including travel insurance, pre and post accommodation, optional activities or excursions and all other ancillary costs.
